Possible nature of Ethical violations

Conflict of Interest: Any action that may result in conflict of interest must be fully disclosed. When impartially and effectiveness cannot be maintained, the activity should be avoided or discontinued.

Disputes about authorship: Proposer authorship representation is usually a matter for the involved parties to resolve.

Duplicate Submission: Duplicate submission is unprofessional; and unacceptable. It misuses the resources all affected journals, including the valuable time of editors, reviewers and staff.

Fabrication of data or results: Any incidence of fabrication shall be considered to be an extremely serious breach of professional conduct, with potentially severe ethical and legal consequences.
